INMATE MAIL PROCEDURES AND REGULATIONS

INMATES MAY SEND AND RECEIVE MAIL WITH EXCEPTIONS. EXCEPTIONS INCLUDE BUT ARE NOT LIMITED TO:

- NO POLAROID PHOTOS
- NO STAPLES, CLASPS, CLIPS OR BRAD ALLOWED ON CORRESPONDENCE
- NO NUDE, EXPLICITLY SEXUAL PHOTOS, PHOTOS INVOLVING INDESCENT BEHAVIOR, OR TATTOO DRAWINGS
- NO METAL, GLASS, HARD PLASTICS OR WOODEN ITEMS
- NO FOOD ITEMS, HYGIENE, OR MEDICAL ITEMS
- WRITING MATERIALS, STAMPS AND ENVELOPES ARE **ALLOWED FOR STATE INMATES ONLY**
- SEXUALLY EXPLICIT MATERIAL IS SUBJECT TO REJECTION
- INMATES ARE ONLY ALLOWED 6 PHOTOS WITH A MAXIMUM SIZE OF 5X7
- GANG MATERIAL, RACISM, EXPLICIT VOCABULARY NOT AUTHORIZED
- ITEMS ATTACHED TO CORRESPONDENCE ARE NOT ALLOWED, I.E STICKERS, GLUE AND GLITTER
- CORRESPONDENCE BETWEEN INMATES INCARCERATED AT THIS FACILITY ARE NOT PERMITTED
- CORRESPONDENCE FROM INMATES INCARCERATED AT THIS FACILITY TO AND FROM ANY OTHER INSTITUTION WILL NEED APPROVAL FROM THE CHIEF OF SECURITY
- CASH AND CHECKS PROHIBITED. MONEY ORDERS ARE THE ONLY FORM OF CURRENCY ACCEPTED AT THIS FACILITY. ANY TYPE OF MONEY ORDER FROM ANY AUTHORIZED SELLER IS ACCEPTED AND SHOULD BE MADE TO: **PRCSO/INMATES NAME**
- THIRD PARTY CORRESPONDENCE (LETTERS SENT THROUGH A SECOND PARTY) ARE NOT AUTHORIZED AND WILL BE HELD FOR EVIDENCE
- BODILY FLUIDS, PERFUMES, COLOGNES, POWDER, HAIR AND LIPSTICK ARE NOT AUTHORIZED
- INTERNET PAGES, NEWSPAPERS, NEWSPAPER CLIPPINGS AND COPIES ARE NOT ALLOWED
- PADDED OR BUBBLE ENVELOPES ARE NOT AUTHORIZED. ALL MAIL RECEIVED MUST BE RECEIVED IN A LEGAL OR LETTER ENVELOPE.

ALL INCOMING AND OUTGOING MAIL IS SUBJECT TO SEARCH AND CENSORED IF THERE IS POSSIBLE EVIDENCE OF CONTRABAND, PLANS FOR CRIMINAL ACTIVITY, INSTRUCTIONS FOR THE MANUFACTURE OF WEAPONS, DRUG, DRUG PARAPHERNALIA, OR ALCOHOLIC BEVERAGES, THREATENED BLACKMAIL OR EXTORTION, CODED CONTENT NOT UNDERSTOOD BY THE READER, OR PLANS FOR ACTIVITIES IN VIOLATION OF THE RULES ENFORCED AT THE PEARL RIVER COUNTY JAIL.

State Work Program Inmates

- * **ONLY ONE** 12x12x12 box per month.
- * Anything larger will be returned to sender.
- * All boxes **MUST be mailed in.**
- * Aluminum cans, Glass, and Perishable food items prohibited
- * Items are to be sent in original purchased packaging. No "homemade" food items.
- * Sugar and sugar substitutes must be individually packaged in original packaging.

All outgoing mail must have a complete return address.
