INFORMATION NEEDED TO FILE FOR
HOMESTEAD EXEMPTION
THE OWNER, SPOUSE OR POWER OF ATTORNEY ARE THE ONLY PEOPLE
THAT MAY APPLY FOR HOMESTEAD

1. CHANCERY CLERK RECORDED COPY OF WARRANTY DEED DEED BOOK AND PAGE MUST BE SHOWN.
2. APPLICANT AND SPOUSE'S SOCIAL SECURITY NUMBER AND BIRTHDAY
3. PURCHASE PRICE OF LAND, HOUSE AND/OR MOBILE HOME. MOBILE HOME MUST BE ASSESSED AS REAL PROPERTY. **IF NEW PURCHASE A COPY OF THE CLOSING STATEMENT MAY BE HELPFUL FILLING OUT THE APPLICATION ACCURATELY**
4. LICENSE PLATE NUMBERS ON ALL MOTOR VEHICLES OWNED BY YOU OR IN YOUR POSSESSION. **THESE MUST BE MISSISSIPPI LICENSE PLATES**
5. IF OVER 65 **ON OR BEFORE JAN 1ST**, BRING PROOF OF AGE (DRIVER'S LICENSE, BIRTH CERTIFICATE ETC.)
6. IF 100% SOCIAL SECURITY DISABLED, BRING **TPOY OR BPOY** OR ORIGINAL AWARD LETTER FOR SOCIAL SECURITY. IN ORDER FOR YOU TO APPLY FOR DISABILITY HOMESTEAD, WE MUST HAVE ONE OF ONE OF THESE LETTERS. WE CAN **NOT** USE THE LETTER THAT STATES THE DOLLAR AMOUNT OF DISABILITY YOU OR YOUR SPOUSE RECIEVES.
7. IF **100% OR PERMANENTLY** SERVICE CONNECTED DISABLED BY VETERANS ADMINISTRATION, BRING LETTER FROM VETERANS AFFAIRS OFFICE.

YOU MUST PROVIDE ALL IN ORDER FOR YOUR APPLICATION TO BE COSIDERED COMPLETE OF THE INFORMATION LISTED ABOVE, PLEASE DO NOT ASK TO MAKE AN APPLICATION FOR HOMESTEAD EXEMPTION. THIS INFORMATION IS REQUIRED BY THE STATE OF MISSISSIPPI AND IS USED IN DETERMINING YOUR ELIGIBILITY. NO APPLICATION WILL BE ACCEPTED UNLESS THEY ARE COMPLETE. ANY INFORMATION REQUESTED BY THIS OFFICE, NOT GIVEN, WILL BE CONSIDERED DENIED AND MAY RESULT IN LOSS OF EXEMPTION.

APPLICATIONS WILL BE TAKEN MONDAY THRU FRIDAY IN THE POPLARVILLE OFFICE AT 100 SOUTH MAIN STREET FROM 8 AM TO 5 PM BEGINNING THE FIRST BUSINESS DAY AFTER JANUARY 1ST AND END ON APRIL 1ST OR THE LAST BUSINESS DAY BEFORE APRIL 1ST. THE OFFICE WILL BE CLOSED ON ALL OFFICIAL HOLIDAYS
