The State requires that you provide the following information to this office

MUST BE IN HOUSE AND/OR MOBILE HOME AS OF OR PRIOR TO JANUARY
1ST OF THE CURRENT YEAR.

Please bring the following information that is applicable to you your situation:

1. Recorded deed, must show deed book and page where recorded (not a deed of trust).
2. Applicant and Spouse's social security numbers and birthdays.
3. Purchase price of land, house and/or mobile home.
4. Phone number and e-mail address of applicant & spouse.
5. Must bring in license plate numbers on all vehicles owned by you. They must be Mississippi plates. (No trailer tags needed)
6. If 100% service connected disabled American veteran, applicants must have car tag letter.
7. If 65 or older as of January 1st of the current year, bring proof of age (driver's license, birth certificate etc).
8. If 100% social security disabled, bring award letter that has the date you were declared disabled, TPQY OR BPQY letter from disability office. We can NOT use the letter that states the dollar amount you receive monthly. If you do not have one of these letters, you must contact the social security office to get one before you can apply for the disability credit.

If you do not have all of the information listed above, the State will consider your application incomplete. This information is required by the State of Mississippi and is used to determining your eligibility. No incomplete application will be accepted.
